The Lake Eunice Township board held the monthly meeting at the town hall on April 9, 2013 at 7pm. All members were present with exception of the treasurer. The minutes from March 11, 2013 were approved by a motion from L Stockert, 2nd by D Opsahl and it carried. Claims were reviewed for payment and transfer of adequate funds to cover payment of claims and payroll was approved as well as the treasurer's report which was reviewed and approved as written by a motion from L Stockert, 2nd by J Rosing and it carried.

Mike Reep, as a representative of the Midnight Riders Snowmobile Club, was present to request the township's support in requesting a 4-way stop at the corner of Co Hwy 6 and Co Hwy 11 from Becker County and MN DOT. J Lightowler made a motion to support this, 2nd by L Stockert and it carried.

Reorganization: D Opsahl nominated J Lightowler as chairman and L Stockert nominated D Opsahl as vice chairman. It was a unanimous decision to appoint them to these positions. Cindy Danielson was appointed as deputy clerk and Sharon Fagerlie as the deputy treasurer. The supervisors will be assigned to the duties as follows: Roads – J Rosing & L Stockert; Weed control – D Opsahl; Signs – W Jacobson.

A road inspection will be done by the supervisors on May 10th at 1pm....meet at the townhall.

The dismissal of the two appeals of the Tanglewood Rd special assessment was received from the Becker County courts.

Based upon inquiries made by several property owners within the Tanglewood Rd Special Assessment District, the Lake Eunice Township Board of Supervisors, after consulting the Becker Co Auditor-Treasurer's Office, hereby makes a motion to waive interest charged on the special assessment subsequent to May 15, 2013 if the full payment of the balance of special assessment is paid to the township by May 15, 2013 (mail time will be given but payment must be received no later than June 1st and the clerk must be notified by May 15th that payment has been mailed and the special assessment payment that is certified on the taxes must be paid to the Auditor's Office). A motion was made by J Lightowler, 2nd by J Rosing and it carried.

A resolution authorizing township supervisors to perform miscellaneous work as necessary at a rate of \$15 per hour was approved by a motion from J Lightowler, 2nd by D Rosing and it carried.

L Stockert made a motion to set a minimum of 2 hours charged for work performed by township board, 2nd by W Jacobson and it carried.

A motion was made to adjourn at 8:15 pm by L Stockert, 2nd by J Rosing and it carried.




