The Lake Eunice Township board held their monthly meeting at the town hall on December 14, 2010 at 7pm. All members were present. The minutes from November 9, 2010 were approved as written by a motion from J Lightowler, 2<sup>nd</sup> by D Opsahl and it carried. The treasurer's report was reviewed and approved as written by a motion from L Kohler, 2<sup>nd</sup> by L Stockert and it carried.

Mike Reep was present asking if all election judges can get paid for attending training. D Opsahl made a motion to approve payment for training of all election judges, 2<sup>nd</sup> by G Johnson and it carried.

Mike Reep questioned whether roads that service only a few residences should continue to be maintained. This was looked at before and there were a few roads that are maintained less often as it is not necessary to be done as often as other roads due to less traffic. Roads will be looked at and consideration made for a maintenance schedule annually when the road inspection is done in the spring.

Software to track road signs would cost \$240/yr with a \$500 initial setup. J Lightowler will bring a sample to the next meeting of an excel program that could do the same thing.

The January 11<sup>th</sup> regular board meeting will also include a budget meeting to develop the proposed budget for 2012.

Ryan Tangen provided a cost schedule for copies, faxes, etc requested by residents that is used by the county. G Johnson made a motion to approve the township using this cost schedule, 2<sup>nd</sup> by D Opsahl and it carried.

A discussion was held regarding the possible future moving of Ellertson Rd for safety issues.

Peterson Ln culvert has been installed.

A motion was made to adjourn at 7:52 pm by L Kohler, 2<sup>nd</sup> by L Stockert and it carried.
