The Lake Eunice Township board held their monthly meeting at the town hall on July 14, 2009 at 7pm. All members were present with exception of the treasurer. The minutes from June were approved as written by a motion from J Lightowler, 2nd by J Renslow, and it carried. The treasurer's report was approved as written by a motion from L Kohler, 2nd by L Stockert and it carried.

Bill Sherlin was present to request the cost to dust control per mile of road. He would like to see if Peterson Circle could be done and if it would be cost effective compared to blading. The township had planned on doing this but it was missed so it will be done on the next run.

Ginger Carlstrom was present to request that Donnie Jay Lane road maintenance be taken over by the township now that there are more residences in this development. The county shows that there are not permanent residences on 50% or more of the lots which was the requirement in this development at the time it was built. There would also need to be an inspection to make sure that the road meets the class A requirements. The board has agreed that it can be looked at again next year and the board will let her know what improvements may be needed to get it up to specs for consideration next year.

Scott Walz was present regarding Blackhawk Country Estates which he is surveying for the bank and is questioning whether each lot needs it's own approach or not and the township stated that they prefer to have them separate so that there are not issues with easements or shared drives.

Scott Hendricks was present and the road maintenance schedule was discussed and any roads he needs to focus on. L Stockert reviewed the road report with the board. A copy is in the file. The board has also started a 5 year plan for the road maintenance. M Reep received the final approval from FEMA to pay for pretty much all the items we stated need repair due to the spring high water. J Lightowler made a motion to have Rick Renner begin the work on Deroxe Rd as per his quote of approx. \$26,000, 2nd by L Stockert and it carried. The cattle crossing on Eilertson Lk Rd will be removed.

J Lightowler has a report from the adoption of zoning which includes an extensive list of things the township would have to adopt which would be a full-time job for both a supervisor and a clerk as well as hiring contractors, etc. The funds would have to be available for paying this labor as well as other costs. We would also have to adapt a minimum of the county standards. At this time it is more than a township of our size can handle, but Joe will do more research on this. He suggests we go to the meetings of the board of adjustments who are the ones that decide on variances.

The board has determined that there is a need for 2 meetings a month during the summer months. L Stocker has made a motion to begin this immediately with a second meeting to happen on July 28th and there will be two meetings in August as well, 2nd by J Lightowler and it carried.

Mark Jacobson wrote a letter asking a few questions which were answered by M Reep in a phone call to him. Stuart Bjorgan was present to state that there is a residence that has a fence on the right-of-way that he was hitting with the mower and he is concerned that it may cause problems. A letter will be sent to this resident (Rick Skogen).

A motion was made to adjourn at 8:53 pm by J Lightowler, 2nd by J Renslow and it carried.
