The Lake Eunice Township board held their monthly meeting at the town hall on July 28, 2009 at 7pm. All members were present with exception of the treasurer. The minutes from July 14, 2009 were approved as written by a motion from J Lightowler, 2<sup>nd</sup> by J Renslow, and it carried.

Gary Fiske representing .... on Bergquist Beach and are requesting a permanent easement be granted for installing a septic. It is policy to allow the septic to be placed up to the township right-of-way but not past this point.

George Hettenbaugh was present to discuss the plans for Eilertson Lake Rd and the repair or replacement of this road is still in the works.

Mike Wamre was present from the Becker County Historical Society on a membership drive. The fee for a township membership is \$100. Some of the township records are already on file at this location. J Lightowler made a motion to approve this membership, 2<sup>nd</sup> by J Renslow and it carried.

J Lightowler found a pickup that could be used for the township work and Lloyd is going to check to see what would be needed to make it adequate to pull the trailer for crackfilling. At this time we will rent a truck for crackfilling to be completed. M Reep made a motion to do this, 2<sup>nd</sup> by J Lightowler and it carried.

L Kohler reviewed the roads repairs that have been completed which includes the cattle crossing on Eilertson Lake Rd as well as roads that are still in progress. Grant Ohm cleaned out the Dahlberg culvert once again. Ellis Peterson of Cormorant Lakes Watershed agreed they would pay for half of the cost of replacing this culvert. Ellis Peterson will do all the legwork to see what is required and the total cost will be \$6800 plus redoing that portion of road once the culvert is replaced. M Reep made a motion to proceed with this project as long as the watershed will also share the cost of the road repair, 2<sup>nd</sup> by J Lightowler and it carried.

Blackhawk Country Estates submitted their notice of a hearing they will be holding to approve the change on the plat from 5 lots to 3 and the township will mail a letter stating that we have no problem with this.

Bill Martodam will be on the agenda for planning and zoning on August 13<sup>th</sup>. L Kohler and J Lightowler will be present at this meeting.

A motion was made to adjourn at 8:17pm by J Lightowler, 2<sup>nd</sup> by J Renslow and it carried.
