On June 7, 2005 the Lake Eunice Township Board held their monthly meeting at the Lake Eunice Townhall. Chairman M Reep called the meeting to order at 7:05 pm. All board members were present. The minutes from May 3rd were approved as written by a motion from L Kohler, 2<sup>nd</sup> by J Maki and it carried. The treasurer's report was approved by a motion from L Kohler, 2<sup>nd</sup> by J Maki and it carried.

## **New Business:**

Jerry Schroeder moving to Willow Lane and is requesting the township take over maintenance of the road. He was informed that there must be 3 permanent residences prior to the maintenance being taken over.

Randy and Janet Salzwedel were present requesting if we have a solution to their water problem on Lake Maud. The supervisors looked at the road and are also aware that this water problem could compromise the road. The ditches will be fixed to correct the grade, rebuild the swail and sod the ditch to keep this from happening again.

Wallace Holm was present from Pearl View Acres stating that the culvert needs to be cleaned out and possibly repaired or replaced. This will be looked at by the supervisors. He also wanted to check the speed limits on the township roads, which is 55mph unless otherwise posted.

L Kohler made a motion to accept Becker County as assessor, 2<sup>nd</sup> by J Maki and it carried.

There was only one gravel quote received which was from EC Anderson. L Kohler made a motion to accept them as our contractor for the gravel, 2<sup>nd</sup> by J Maki and it carried.

Jeff Moritz was present from Tanglewood Rd requesting permission to place stone on the upslope of the ditch where his evergreens hang over to prevent the grass from getting overgrown.

There will be letters sent to people on Tanglewood Road to remove trees they had planted in the township right-of-way.

Jeff Moritz also would like us to initiate a no-wake zone or minimum wake zone in the near future with some sort of a long term automatic no wake zone clause if the water reaches a certain level. A letter was received from residents of Sugar Island requesting repair of their culvert, replace signs, repair ditches, fix soft spots and widen their road.

There was a discussion of possibly paving 3 township roads under a general bond issue. The soft spot on Deroxe Rd will be repaired as well as Morton Oaks by digging out, putting down a mat and culvert if needed and possibly tar next year.
