The Lake Eunice Township board held their bi-monthly meeting at the town hall on June 8, 2010 at 7pm. All members were present. The minutes from May 25th were approved as written by a motion from L Stockert, 2<sup>nd</sup> by G Johnson and it carried. The treasurer's report was read and approved by a motion from L Kohler, 2<sup>nd</sup> by J Renslow and it carried.

L Stockert would like to make a motion to retract the decision of not dust controlling spots on special occasions with a minimum of 500ft, 2<sup>nd</sup> by G Johnson and it carried.

Tom Trautman, Jerry McCann and Steve Walz were present to request dust control on a portion of Moe Lake Rd. L Stockert made a motion to apply 200ft and 14ft wide of dust control applied in front of each of their homes at a cost of \$270 total and half paid by the township, 2<sup>nd</sup> by L Kohler and it carried.

Residents of Meadow Lane were present with a petition to dust control the first ½ mile of the road. G Johnson made a motion to accept the petition, 2<sup>nd</sup> by L Kohler and it carried. (14' wide)

Dave Kragnes of W Lake Eunice Rd was present with a petition to vacate the unused dedicated platted road on Bergquist Beach and petition to declare public road location which included a description of the requested portion. A hearing will be scheduled for this vacation.

Road Repairs quotes:

- E Arrow Rd 270' blacktop patch: Driveway Svc \$6,500 + \$900 more for 3" / Mohawk \$11,119
- L Kohler made a motion to have Driveway Svc complete this project with 2 1/2", 2<sup>nd</sup> by G Johnson and it carried.
  Erickson Rd 460': Hough \$15,225 / Olson Construction \$11,000 / Mohawk \$18,150 / Driveway Svc \$13,750 L Stockert made a motion to have Olson complete this project, 2<sup>nd</sup> by G Johnson and it carried.
- Dahlberg Culvert 24' x 22' asphalt: Mohawk \$1,856 / Driveway Svc \$1,500 G Johnson made a motion to have Driveway Svc complete this project, 2<sup>nd</sup> by J Renslow and it carried.

Luxury Landscape are not able to clean up the compost site, level and seed it and L Stockert made a motion to have Renner complete this project as he was the next closest quote, 2<sup>nd</sup> by G Johnson and it carried.

G Johnson received quotes for maintaining the townhall yard: Ken Svare \$50 per mowing and trimming / Stu Anderson \$75 / Mike Wicker \$35. G Johnson made a motion to have Mike Wicker do the maintenance, 2<sup>nd</sup> by J Renslow and it carried.

Lowell Grubb of Sportsmen Rd have requested speed signs by their home. G Johnson recommended the "watch for children" signs be placed at a further distance so people have time to slow down. M Reep stated that the township could place an advisory 35mph sign by the children signs. L Stockert made a motion to have the county install 2 stop signs at the junction of Kohler Rd and W Arrow Rd as well as the 35mph advisory signs on Sportsmen Rd, 2<sup>nd</sup> by G Johnson and it carried.

L Kohler looked at Dahlberg culvert and Danny Olson will complete the rip rap repairs and he will talk to the county about spraying noxious weeds and those that do not require a permit will be done by L Kohler and L Stockert. L Kohler made a motion to allow Jeff Molander to pave a portion of his road with 2 <sup>1</sup>/<sub>2</sub>" of compacted asphalt plus 6" of class 5, 2<sup>nd</sup> by L Stockert and it carried.

Dennis Peterson submitted a bill for snow removal on Becker 6 and G Johnson made a motion that the township is unable to pay the bill as this is an individual and is not covered by our insurance, 2<sup>nd</sup> by J Lightowler and it carried.

J Lightowler made a motion to officially name Erickson Rd as Erickson Rd and not Norm Erickson Rd, 2<sup>nd</sup> L Stockert and it carried.

Tarnowski Rd will be maintained as a minimum maintenance road as the only resident is not there much in the winter and she, Sharon Tarnowski, will contact the township when she will be there to have it plowed.

Bill Martodam requested a variance for building his attached garage. J Lightowler made a motion to recommend denial to the County, 2<sup>nd</sup> by J Renslow and it carried.
