The Lake Eunice Township board held their monthly meeting at the town hall on May 1, 2007 at 7:05pm. All board members were present. The minutes from April were approved as written by a motion from M Reep, 2<sup>nd</sup> by L Kohler and it carried. The treasurer's report was approved by a motion from M Reep, 2<sup>nd</sup> by L Kohler and it carried.

The July meeting will be changed to July 10<sup>th</sup>.

Gravel quotes were accepted and one was received from Ernest C Anderson Gravel Inc for \$5.15 per ton delivered and including tax. This included the details of a fuel surcharge. M Reep made a motion to accept this quote to begin immediately, 2<sup>nd</sup> by L Kohler and it carried.

N Pearl Lake Rd will be worked on as there were a few complaints about this road and their concern with the gravel being a decent blend for class 5. The gravel will be taken to the county for testing by the board supervisors. There will also be a consideration of the need to add clay to the mix on this road. A traffic counter will be placed on this road to get an idea of what the traffic flow is and the need for asphalt for maintenance reasons. The board will look at the rules involved with speed limit signs that might be able to be placed on this road.

Howard Ellingson, Tim Nerdaahl and Gary Schander were present from Buckhorn Rd about the possibility of approaching the DNR again about assistance for asphalt on this road due to lake access and the excessive traffic flow. M Reep and L Kohler will contact some people about how to go about making this happen.

A resolution was presented from the City of Detroit Lakes concerning the JOBZ program for a portion of land on #6 in the former SJE Rhombus building to be used by CHS Industries with the possibilities of producing 20-40 new jobs in the area. This will be checked into further to obtain more information and reviewed by the township attorney.

Mike Hough was present to discuss Nelson Market Rd. The township is requesting that Hough provide clay for the road and the township will take care of spreading it and working it into the road. They agreed to work with us on getting this accomplished as soon as road restrictions are removed. The road will be worked back into being regulation width and we will work on the ditches on Nelson Rd.

Dust Control will be done on several of our roads by DM Dust Control this year so that the timing can be scheduled. Lloyd Kohler made a motion for the township to pay for 1/2 of the cost of the dust control on any township road as requested by the residents, 2<sup>nd</sup> by M Reep and this will be discussed with the attorney as to how this needs to be handled.

Road inspection will be done on May 7, 2007 at 9am to determine what roads need repair, gravel, etc.

A motion was made by M Reep to adjourn at 9:25pm, 2<sup>nd</sup> by L Kohler and it carried.
