The Lake Eunice Township board held their monthly meeting at the town hall on May 12, 2009 at 8:30pm (postponed due to special election). All members were present. The minutes from April were approved as written by a motion from L Kohler, 2nd by J Renslow, and it carried. The treasurer's report shows the budget on the general fund is at 50% which is due to not accounting for the loan payments that were due and was approved as written by a motion from L Kohler, 2nd by J Renslow and it carried.

Election results were read as follows: 136 total votes....

Joe Lightowler - 70.... Larry Stockert - 66.... Scott Rietsema - 57..... Dave DeMars - 55.... Dave Opsahl -26

Jay Tweten on Summer Island Rd was present concerning a tax issue on his property and wanted to know if anything is going to be vacated and that is not going to be done at this time. L Kohler made a motion for the county to abate those taxes as it will not be vacated at this time, 2nd by J Renslow and it carried. It was stated to him that the portion that he wants vacated is part of the township right-of-way and therefore nothing can be parked or stored on this portion. It was recommended by M Reep that he should approach the board again after he determines that a replat would give the township enough of a segment for a proper right-of-way as well as leaving a buildable lot.

Jan Bauer was present to request to put a hair salon at her home and was told she needs to talk to zoning about this matter.

A quote was received to reposition Eilertson Lake Rd in order to improve the quality so it can be properly maintained. This will be decided on at a later time.

A meeting with FEMA will occur Wed, May 13th at M Reep's house to discuss what can be done for the township and what funds are available to us. This is the 3rd meeting that has occurred with FEMA according to M Reep. We have received quotes for the cost of the repairs that will be needed.

One quote was received for gravel hauling and spreading by Orvis Olson Gravel for \$10.50 per yd delivered and spread. This will not be decided on at this time.

The road report was submitted by J Renslow and was reviewed as to what needs to be done on the roads this year.

L Kohler made a motion to hold the hearing for the vacation of W Little Cormorant Rd at 6pm on June 9, 2009 on site for an inspection by the board and reconvene at 7:30pm at the townhall, 2nd by J Renslow and it carried.

Josh Kavanagh from Ducks Unlimited was contacted to clean out the culvert between Dahlberg and Leaf Lake. He reassured us that they would make sure it was taken care of now and in the future.

Hough was present to state that he would like to have the dust control put on the road again and would like to be notified so he can do it at the same time. Also, he stated that the entrance to the pit on the Nelson Market side is closed at 5pm and they are keeping the roadway cleaned up as well.

J Renslow made a motion to have Lloyd pick up supplies for crackfilling (reflective vests and working signs), 2nd by M Reep and it carried.

A motion was made to adjourn at 9:20pm by L Kohler, 2nd by J Renslow and it carried.
