The Lake Eunice Township board held the monthly meeting at the town hall on September 11, 2012 at 7pm. All members were present with exception of J Rosing. The minutes from August 13, 2012 were approved as written by a motion from L Stockert, 2<sup>nd</sup> by D Opsahl and it carried. Claims were reviewed for payment and transfer of adequate funds to cover payment of claims and payroll was approved as well as the treasurer's report which was reviewed and approved as written by a motion from L Stockert, 2<sup>nd</sup> by G Johnson and it carried.

The Fugere hearing for the vacation of a portion Maple Lodge Rd was held at 7:05pm. L Stockert made a motion to accept the resolution for vacation, 2<sup>nd</sup> by D Opsahl and it carried.

Heather and Richard Anderson were present to discuss a variance for a wall that has been built along their driveway and is in the road right of way. They are also requesting that an ordinance be adopted to require snowmobiles to use the public trail instead of using the ditch for safety purposes. The township will check with the attorney about the placement of this landscaping on this property.

Rick Renner was present requesting a drainfield be placed in the right-of-way across from 15838 E Little Cormorant Rd. L Stockert made a motion to approve this request, 2<sup>nd</sup> by D Opsahl and it carried.

D Opsahl made a motion to approve the clerk, Crystal Myers, and the chairman, Joe Lightowler, to sign the paperwork on September 17, 2012 for the Certificate of Indebtedness in the amount of \$306,332.34 at State Bank & Trust at an interest rate of 5% for 10 years for the road project on Tanglewood Rd which will be assessed to the property owners, 2<sup>nd</sup> by G Johnson and it carried.

The assessment hearing for Tanglewood Rd will be held at the townhall at 7pm on September 25, 2012.

Jeff Molander & Gene Hanson called the township and are requesting paving a portion of the road on E Pearl Lk Rd and they will pay for the paving and would like the township to fix the soft spot and do the shouldering. The township has requested that they attend a meeting so the process of petition and other paperwork be explained and discussed.

A motion was made to adjourn at 8:15 pm by L Stockert, 2<sup>nd</sup> by D Opsahl and it carried.
